Sir,

Referring to the case of the Hindu H. Rahim, I beg to state that this matter came up before Mr Justice Gregory and a Jury at the Assize, on the 2nd inst. The accused pleaded "Not Guilty" to the charge, and his lawyer, Mr G. E. McCrossan, raised a very ingenious defence. Of the two indictments that were returned by the Grand Jury against Rahim, to wit, first, that of having his name placed on the Voters list, being a Hindu, and the second, that of voting in the election, the second was quashed while the Judge upheld the first, and on this count the matter went to trial.

Mr McCrossan's contention was that the Act reads "No Hindu shall have his name placed on the Voters list" and there was no direct evidence to prove that Rahim ever did this, but it was at the same time pointed out by the Prosecuting Counsel that it is impossible for any Hindu to place his name on the Voters list himself and it must be done through the regular channel and this had been done in the present case inasmuch as Rahim had signed a declaration which evidently had been sworn to before Mr W.E. Flumerfelt, and as this declaration had evidently reached the Registrar of Voters and by him on the 6th of November last, when he sat as a Court of Revision, passed and placed on the Voters list completed

the necessary formalities by which the name should be placed on such list. Evidence was given to prove that Rahim was a Hindu, the signature on the declaration was proved as his, but Mr Flumerfelt could not identify, and did not know, the accused, hence there was a break in the chain of the evidence. However the fact that Rahim took an active part in the Elections, being a Scrutineer for the Socialists, and also having voted, carried weight and brought out the fact that he was taking advantage of his name being on the Voters list. Rahim ~~was~~ did not give evidence on his own behalf hence we were unable to secure any statements from him in connection with the present charge or his antecedents.

The case went to the Jury who after two and a half hours deliberation could not agree and were discharged by the Judge, who ordered Rahim's release on his own recognizance for the sum of \$1000.00 pending his retrial either at this or at the next Assizes, and at the same time asked the Prosecuting Counsel to refer the case to the Attorney General, with a view, if possible, of withdrawing the charge or some such action.

The papers etc found in Rahim's house were not produced as exhibits as they were not needed, Rahim not giving evidence on his own behalf, I am
