Cst. Damod contacted the SW. was told to have the drug, which was for personal use handed over)</p> <p>In file 92-5762, Cst. Damod while on patrol, discovered 3 males acting suspiciously outside a local bar. A clear look revealed one of the men holding on to a baggie of amphetamine which Cst. Damod subsequently seized with charge pending.</p> <p>File 92/5122 - Cst. Damod has been doing for periods at night of an apartment block known to residents for a variety of problems it presented a known drug dealer acting in a suspicious manner, with a subsequent search turning up enough evidence to support a prosecution for the purpose charge. Unfortunately, due to inexperience, Cst. Damod did not lay the correct legal groundwork prior to the actual search and as a result a charge will result.
